

House Rules for Visitors to the Shenyang New World EXPO

Compliance with these House Rules is a condition for admission to the Shenyang New World EXPO (EXPO). All visitors are requested to acquaint themselves with these House Rules and abide them at all times.

1. EXPO reserves the right to:

- Require any person who has entered but failed to comply with these House Rules, to leave EXPO immediately;
- Refuse admission to any person;
- Ask any visitor to open any bag or parcel, and inspect the contents;
- Photograph, film, videotape, record or otherwise collect and preserve the image and/or voice of any person who enters EXPO, and use for any purposes associated with the management of EXPO;
- Seek compensation (through legal process if necessary) for any damage caused to any property, EXPO's management or an EXPO event by visitors; and,
- Require any person to stop and refrain from any behavior that is dangerous or that may
 endanger the safety of the visitor, or other users, or the rights of other users to enjoy the
 space, or give rise to a risk of damage to the property of the EXPO or any third party.

2. The following are forbidden at all times:

- Smoking, including carrying any lighted cigar, pipe, cigarette or use of e-cigarette;
- Spitting or littering;
- Behaving in an offensive, aggressive, unlawfully, unsafe or violent manner;
- Using abusive, intolerant, discriminatory or profane language;
- Damaging, defacing or altering the appearance of any structure, property, sign or equipment;
- Using any sort of sound or light amplification device, including, but not limited to, all forms
 of air-horns, loud-hailers and megaphones, and laser pointers;
- Carrying out unauthorized photography, video-taping or recording of any kind of broadcast or transmission;
- Bringing any animals into EXPO, with the exception of certified and approved service animals for physically challenged persons;
- Selling goods or services, or displaying goods or services for sale, without the consent of EXPO and event organizers;
- Displaying any flag, banner or other emblem without authorization;
- Using radio or otherwise remotely controlled devices without the consent of EXPO;
- Entering or remaining in any area of the venue not open to the general public;
- Bringing any sort of dangerous or hazardous material into EXPO;





- Promoting, soliciting, selling or bartering any admission ticket or item for more than its face value;
- Conducting, leading, or participating in any unauthorized gatherings, demonstrations or expression of public opinion that disrupt or restrict crowd management relative to EXPO events;
- Consuming any food or drink that has not been purchased from a licensed EXPO outlet and consumed in an area designated for that purpose;
- Other than by prior agreement and with the express permission of EXPO, the bringing in
 of any outside purchased food or beverage to any area under EXPO management, licensed
 or otherwise, regardless of whether it is for personal consumption or delivering to others;
- Any behaviour that is dangerous or that may endanger the safety of the visitor, or other
 users, or the rights of other users to enjoy the space, or give rise to a risk of damage to the
 property of the EXPO or any third party; and,
- Promoting, including, but not limited to: distributing any material or items of any kind, including leaflets or printed material of any kind, soliciting visitors whether for business or any other purpose, or undertaking any kind of questionnaire or poll, without the consent of EXPO.

3. Public Health provisions and compliance:

EXPO requires all persons entering any part of the EXPO premises to comply with all Laws, Legislation and Government Guidelines relating to Public Health and the prevention of the spread of communicable diseases. Any person failing to comply with these requirements (e.g. refusing to wear a facemask, failing to present their "Health Code" "State Council Travel History Code," or not having their temperature checked, or any other conditions that EXPO may, from time to time, announce), will be denied entry and must leave the EXPO immediately.

4. To ensure the safety and wellbeing of all, visitors are asked to:

- Supervise children and take care of the elderly;
- Take care of and be responsible for their own personal property;
- Stand still on escalators and hold the handrail;
- Refrain from pushing, running, boisterous behavior and queue-jumping;
- Show respect for all guests and users of EXPO; and,
